

**AMENDMENT TO THE DIRECTIONS ISSUED IN TERMS OF THE REGULATIONS MADE UNDER SECTION 27(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002): MEASURES TO ADDRESS, PREVENT AND COMBAT THE SPREAD OF COVID -19**

I, Dr Zwelini Lawrence Mkhize, in terms of regulation 4(1)(b) of the Regulations issued in terms of the Disaster Management Act, 2002 (Act No. 57 of 2002) hereby amend Government Notice No.457 published in Government Gazette No.43217 of 08 April 2020 and Government Notice No.589 published in Government Gazette No.43350 of 25 May 2020, as set out in the Schedule.

**SCHEDULE**

1. Substitution of Direction 8N of the following directions.  
**"Cost of quarantine**

**8N.** Where exceptional circumstances make it necessary for the mandatory quarantine of a person returning to the Republic to take place in a manner which involves the incurring of additional costs beyond those ordinarily incurred as a result of mandatory quarantine, the Director-General: Health may direct that such person is to pay the additional costs concerned."

2. These Amendment Directions come into effect on the date of publication in the Government Gazette.
